There are two (2) divisions within the Great Falls Adult Education Department:

- **The Adult Education Center**
 - Employment and/or College Readiness
 - ELA (English Language Acquisition)
 - Preparation for the HiSET (*High School Equivalency Test*)
- **The HiSET Exam Center (HiSET Exam Replaced GED Test)**
 - Paper or Computer-Based Test

Adult Education Center

A No-Cost Placement Test (TABE-Test of Adult Basic Education) or the BEST Plus) is required to access the following **free** services*

- Pathway Plan
- Prepare for Higher Education/Employment
(salon academies, trade schools, apprenticeships, certification programs, 2 or 4 year colleges, etc.)
- Increase Employability Skills
- Improve Job/Career Opportunities
- Montana Career Information System (MCIS)
- Assess/Increase Digital Literacy (technology/computers)
- Build Literacy Proficiency
- ELA (English Language Acquisition)
- Distance Learning
- Preparation for the HiSET Exam

***Orientation, advisement and a minimum amount of attendance beyond the TABE or BEST Plus are considered part of a student's obligation for accessing our Adult Education Center. ***

HiSET Exam Center

For those interested in taking the **HiSET Exam Only** without accessing services offered through the Adult Education Center:

The HiSET Exam consists of 5 Individual tests:

Language Arts Reading, Language Arts Writing, Social Studies, Science, and Mathematics

Eligibility Requirements:

- Must be 17 or older to test
- If you are 17 or 18, **additional paperwork is required**
- Proof of Montana Residency
- Government Issued Identification

Cost:

- Individual Tests: **\$10.00 each**
(Paid on-line & includes two re-takes per individual test)

Test costs are paid online in conjunction with registration and scheduling and are valid for one (1) year from time of purchase. You cannot take each of the five tests (including retakes more than three (3) times in a calendar year.

- Test-Center Fee: **\$ 5.00** one-time fee
(paid in cash when you complete required paperwork)

Once on-line registration is complete, the test-center fee and a signed publicity release are required at least one (1) hour before testing. You will not be allowed to enter the testing room without a receipt & gov't issued photo ID.

Testing Schedule: Every Tuesday

- 8:00, 9:30, 11:00am - Paper-Based Only
- 5:00, 6:30, 8:00pm - Computer-Based Only
